


## Change in Number of Firms and Gross Receipts for Firms in Indiana 1997 - 2002

- In 2002, there were about 27,150 minority firms in Indiana generating over \$5.3 billion in gross receipts.
- These firms also employed nearly 37,800 workers.
- Minority firms represented 6% of all 'classifiable' firms located in the state.
- The number of minority firms in Indiana increased by 19% between 1997 and 2002, compared to 4% for all 'classifiable' firms in the state.
- Indiana had the 27<sup>th</sup> largest minority population in the country, numbering nearly 897,000 or 15% of the state's total population in 2002.


## Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, Indiana– 2002



- In Indiana only Asians have reached parity in their number of firms when compared to their representation in the state's population. No other minority group has reached parity in the number of firms and gross receipts.
- If minority business activity in Indiana matched the state's minority population percentage in 2002, the number of minority firms in the state would have exceeded 61,000 and they would have generated nearly \$27 billion in gross receipts and employed more than 177,000 workers.

Table 2: Estimates of the Total Population of States by Race and Hispanic Origin: July 1, 2002. All U.S. Firms include publicly-held, foreign-owned and non-profit firms. Statistics for All Minority, Classifiable Firms and all groups do not include publicly-held, foreign-owned and non-profit entities. Classifiable Firms include minority-owned and non-minority-owned firms. These are firms whose ownership can be classified by race, gender of Hispanic origin. Total numbers for Classifiable Firms represent MBDA estimates. Hispanics may be of any race, because business owners were allowed to identify with more than one race category. S = Estimates are suppressed when publication standards are not met. Due to the exclusion of tribally held governments in 2002, data for American Indian and Alaska Native firms for 1997 and 2002 are not directly comparable. Growth measures for Native Hawaiian and Other Pacific Islanders are not represented because 1997 data was withheld. Population estimates for 2002 were for all ages.

## Minority Firms in Indiana by Gross Receipts Size, 2002



- While smaller in number, Strategic Growth Initiative (SGI) minority-owned firms, which have annual receipts of \$500,000 or more, generate a much larger percentage of all the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, minority-owned firms with receipts of \$500,000 or more generated about 79% of all receipts grossed by all minority firms in Indiana and employed 71% of all paid workers employed by minority firms in that state.
- Minority-owned firms in Indiana were also more concentrated in the following industries: health care and social assistance; other services; retail trade; and professional, scientific, and technical services.

S = Estimates are suppressed when publication standards are not met. Total percentages for minority firms by industry may exceed 100% because some firms may be classified in more than one industry.
