DONOVAN ANNOUNCES HUD'S FY2014 BUDGET: Proposed plan builds on efforts to grow middle class, protect housing for extremely poor. On April 11, HUD Secretary Shaun Donovan released details of the Obama Administration's proposed FY2014 HUD Budget, a plan that seeks to protect rental housing and homeless assistance for millions of extremely poor Americans while increasing key investments in initiatives to serve some of the nation's most distressed neighborhoods. SENATE COMMITTEE ON INDIAN AFFAIRS REQUEST FOR TRIBAL COMMENTS ON NAHASDA REAUTHORIZATION: The Senate Committee on Indian Affairs is requesting tribal comments or recommendations for the reauthorization of the Native American Housing and Self Determination Act (NAHASDA). The Committee is moving quickly to consider NAHASDA Reauthorization before the expiration of the current authorization on September, 30, 2013. (IHS) FY2014 BUDGET INCREASE: As part of President Barack Obama's proposed Fiscal Year 2014 budget, Indian Health Service (IHS) is slated to see a 2.9 % increase. The overall Indian Health Service is \$4.4 billion. This is a \$124 million increase over the FY 2012 appropriation. Tribal consultation is fundamental to the IHS budget process, and the proposed budget incorporates tribal priorities and recommendations. The budget request supports and expands the provision of health care services and public health programs for American Indians and Alaska Natives. It includes these approximate increases:

\$35 million to help purchase health care from the private sector through the Contract Health Services program, which is under proposal to be called the Purchased/Referred Care program.

\$77.3 million to support staffing and operating costs at new and replacement facilities

\$5.8 million to fund contract support costs incurred by tribes in managing their own health programs.

Funding was also included to continue construction of a health care facility in **Kayenta**, **AZ**, and to complete construction of a health care facility in **San Carlos**, **AZ**, and the Southern California Youth Regional Treatment Center near **Hemet**, **CA**. If the proposed budget is enacted, the IHS discretionary budget will have increased 32 % since FY 2008. The IHS FY 2014 proposed budget is available online at www.ihs.gov/BudgetFormulation. The IHS, an agency in the US Dept of Health & Human Services, provides a comprehensive health service delivery system for approx. 2.1 million American Indians & Alaska Natives who are members of federally recognized tribes.

Native American Rural Business Enterprise Grants (USDA-RD)	Contact your local USDA Rural Development office for due dates	Grant program to develop small & emerging private business opportunities in tribal & rural areas. Program provides grants for rural projects that finance the development of small and emerging rural businesses, and help fund distance adult learning for job training and advancement. Small & emerging private businesses are those with fewer than 50 employees with less than \$1 million in projected gross revenues. USDA-RD expects to award approx. \$3.2 million via a single national competition. There is no state set-aside for this program; Native American RBEG applications compete with other Native American RBEG applications from around the nation. For a tribally owned business to be considered private, it must be held through a separate entity such as a tribal corporation. The corporation may be owned by the tribe and distribute profits to the tribe. However, the governing board must be independent from the tribal government & elected or appointed for a specific time period. ALBERT SMITH, NAVAJO CODE TALKER FROM NM, PASSES ON: Albert Smith, a Navajo Code Talker from New Mexico, died on Wed. He was 88. Smith lied about his age in order to enlist in the U.S. Marine Corps at the age of 15. He used the Navajo language to transmit unbreakable codes during World War II. "He will be greatly missed, yet his legendary life and service to the United States will live on in our hearts forever," a posting on the Facebook page of Our Navajo Code Talker said in announcing Smith's passing. CUMASH TRIBAL ELDER APPOINTED TO CA NATIVE AMERICAN HERITAGE COMMISSION: Reginald "Reggie" Pagaling, a Santa Ynez Band of Chumash Indians tribal elder, was recently appointed by Gov. Jerry Brown to the California Native American Heritage Commission. Pagaling, 59, is a member of the Chumash Maritime Association and has devoted much of his time to restoring the tribe's ancient maritime culture and also serves on the Santa Barbara County Local Community Benefit Committee. The nine-member Native American Heritage Commission was established in 1976 to preserve and protect tribal burial grounds from vandalism and destruction. Commissioners work closely with the public, developers, local and federal agencies, educational institutions and California Native Americans to provide advice and assistance toward the protection and preservation of Native American cultural resources.

TRIBE LEADS COAL TO CLEAN ENERGY WALK IN MOAPA (Associated Press 4/20/13): Moapa Band of Paiutes tribe members led a 16-mile Earth Day weekend walk to put the spotlight on plans to close a coal-fired power plant and build a solar energy plant in Southern Nevada. Activists and faith leaders joined the Coal to Clean Energy walk Saturday from NV Energy's Reid Gardner generation station to a planned 350-megawatt solar project on the Moapa Paiute Reservation. The march took place about two weeks after NV Energy announced plans to begin closing Reid Gardner and invest more money in renewable energy. Plans call for Nevada's largest utility to close three of four units by 2014 at the coal-fired plant in Moapa about 40 miles northeast of Las Vegas. The fourth unit would remain operating until 2017. The Moapa Band of Paiutes has been fighting for years to force publicly traded NV Energy to decommission the plant. They say tribal members living on ancestral land have been sickened by soot, fine particles of pollution and gases. U.S. Senate Majority Leader Harry Reid expressed support for Saturday's march. "The Moapa Band of Paiutes is an important voice for Nevada's transition towards a cleaner, more sustainable energy future," he said in a statement. NV Energy plans to construct, acquire or contract for 600 megawatts of renewable energy in Nevada during the next five years — marking the first time the utility owns and operates renewable energy power plants. The company also plans to construct or acquire and own 1,000 megawatts of natural gas energy during the next five years and 1,000 more megawatts in the next 10 years with construction or acquisition intended to be in-state.

MRS. BIDEN VISITS NAVAJO TECHNICAL COLLEGE: Dr. Jill Biden will deliver the commencement address at Navajo Technical College (NTC) on May 17 in Crownpoint, NM. NTC was recently recognized for the second consecutive year by the Aspen Institute College Excellence Program as being one of the top 120 community colleges in the United States. Navajo Technical College is one of two tribal colleges serving the Navajo Nation, and has a graduation rate of nearly eighty percent. Dr. Biden has been an educator for nearly thirty years, and continues to teach English at a community college in Northern Virginia. Biden will address the 33rd graduating class of NTC.

18th ANNUAL PECHANGA POW WOW – JUNE 28-30: Families, spectators and tribal participants from across North America will descend June 28-30 on the festival grounds at Pechanga Resort & Casino for the 18th Annual Pechanga Pow Wow in southern CA. The

2013 NABI BASKETBALL TOURNAMENT TO HOST 128 TEAMS — July in Phoenix, AZ - The NABI Foundation, known for organizing high profile sporting events for Native American athletes, will host 128 teams (64 boys & 64 girls' teams) for their 11TH Anniversary NABI Invitational taking place this July 17-21 in Phoenix. For years the tournament has attracted teams representing tribes from all across the US but this year there will also be teams from Canada and New Zealand representing their indigenous people and hoping to bring home the NABI Championship trophy. NABI, co-founded by Mark West of the Phoenix Suns, the late Scott Podleski and GinaMarie Scarpa started out as a small local tournament in 2003 and since has become a youth non-profit organizing one of the largest all Native American tournaments; bringing exposure to thousands of Native American High School athletes from all over North America. Along with a record number of teams, Ak-Chin Indian Community, Nike N7 and Yavapai Prescott Indian Tribe will be the presenting sponsors of this prestige tournament. Games will be played in 10 Phoenix area gyms starting July 18th with the NABI Championship games being played at US Airways Center on July 21st. Registration closes May 1st. <u>UPDATE - ROCKY MOUNTAIN SPOTTED FEVER IMPACTING TRIBAL COMMUNITIES:</u> The Centers for Disease Control (CDC) and Arizona Dept. of Health Services announced statistics for cases of Rocky Mountain Spotted Fever (RMSF) in several southwestern Native American communities. Between 2003 and 2012, more than 200 cases, including 19 deaths, have been reported in multiple reservations in Arizona. Children are especially vulnerable to RMSF and incidences of the disease dramatically increase in the summer months between April and November. The disease is spread by ticks that are carried on animals, primarily dogs, who transfer the disease to humans. To prevent spread of RMSF, everyone is encouraged to (1) protect dogs with tick collars, (2) treat homes and community buildings for tick infestation, (3) report cases to health professionals, (4) control animal populations (spay and neuter pets), and (5) educate community members about the dangers and preventative measures for controlling the spread of RMSF.
