




Change in Number of Firms and Gross Receipts for Firms in Washington, D.C. 1997 - 2002

- In 2002, there were over 16,800 minority firms in Washington, D.C. employing between 25,000 to 49,999 employees.
- Minority firms represented 38% of all 'classifiable' firms located in the district.
- The number of minority firms in D.C. increased by 10% between 1997 and 2002, compared to 7% for all 'classifiable' firms in the district.
- Washington, D.C. had the 36th largest minority population in the country, numbering about 412,000 or 72% of the district's total population in 2002.


Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, in Washington, D.C. – 2002



- In 2002, only Asian Americans reached parity in their number of firms and total gross receipts. No other minority group reached parity.
- If minority business activity in Washington, D.C. matched the city's minority population percentage in 2002, the number of minority firms in the district would have exceeded 31,700. They would have generated \$13 billion in gross receipts and employed more than 91,300 workers.

Minority Firms in Washington, D.C. by Gross Receipts Size, 2002



- While smaller in number, minority-owned Strategic Growth Initiative (SGI) firms, which have annual receipts of \$500,000 or more, generate a much larger percentage of all the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, SGI firms generated about 79% of all receipts grossed by all minority firms in D.C. and employed 67% of all paid workers employed by minority firms in that city.
- Minority-owned firms in D.C. were also more concentrated in the following industries: professional, scientific, and technical services; other services; and health care and social service.
